On March 1, 2012, the Court proposed that the undersigned mediate the 20 remaining cases in this MDL against GEHC in Room 18B of the Carl B. Stokes United States Court House, 801 West Superior Avenue, Cleveland, Ohio at **9:00 a.m. Eastern Time on Monday, April 23, 2012**. The above-listed plaintiffs have agreed to participate. All plaintiffs or a family representative with full settlement authority must attend this settlement conference **in person**.

In preparation for the mediation and in order to maximize the chances for settlement, each plaintiff's counsel shall prepare a 2-3 page submission on each case, with a monetary demand, **no later than by 4:00 PM Eastern Time on Thursday, April 5, 2012**. These submissions shall be sent to all other plaintiffs' counsel in the mediation, GEHC, Cathy Yanni, and the Court.

No later than 4:00 PM Eastern Time on Tuesday, April 17, 2012, GEHC is to send a responsive 2-3 page submission on each case to all plaintiffs' counsel, **Cathy Yanni, and the Court. GEHC may either include in these submissions an individual offer for each case, or an aggregate offer for the entire pool of 18 cases.**
