GE HEALTHCARE'S STATEMENT OF REMAINING CASES

I. <u>Introduction</u>

The GE Healthcare Defendants ("GEHC") submit this response to the Court's March 1, 2013 request for a report regarding its remaining unresolved cases with respect to remand. Other than nine (9) active cases¹, GEHC resolved all of its remaining cases. As detailed below, GEHC settled an additional five (5) cases since its March 8, 2013 submission, has been dismissed from 19 cases, and was not named in the 13 other cases identified on the Court's list of active cases.² GEHC submitted an individual report on the status of each of the nine unsettled cases under their respective case captions.
