By Settlement Implementation Orders Nos. 3 through 3J, the Court approved an aggregate of \$2,035,753.90 in out-of-pocket costs reimbursements for approximately 2,700 PSC and non-PSC opt-in claims.

The undersigned counsel, after consultation with counsel for Defendants, now respectfully submit this Interim Report 3K concerning 17 additional requests for reimbursement of case-specific "opt-in" expenses filed by 11 non-Plaintiffs' Steering Committee attorneys since the Court entered Settlement Implementation Orders Nos. 3 through 3J. Two of these claims were filed after the December 1, 2001 deadline for filing Claim Forms to Request Fees and Costs, and written explanations were provided. This Report is based on an analysis of all 17 Claim Forms and the supporting records and data submitted, accepting all those claims as appropriate to recommend for payment.

Attached to this Interim Report 3K is a chart that identifies the firms which submitted claims, aggregated by petitioning firm and expense category. Also submitted is a separate chart, filed under seal, listing each individual claim, including the names of the injured persons. The chart, which identifies the firms that submitted claims, is aggregated by petitioning firm and by expense category. The chart lists the expenses that appear to be adequately documented and appropriate for reimbursement. The overall aggregate amount requested for reimbursement is \$14,844.66.
