ORDER SCHEDULING ORAL ARGUMENTS FOR MASTER SETTLEMENT AGREEMENT ELIGIBILITY/ALLOCATION APPEALS

Pursuant to the Master Settlement Agreement ("MSA") dated March 24, 2014, and pursuant to the April 10, 2014, Order of District Judge John F. Keenan, this Court has been appointed as the General Special Master responsible for the hearing of all eligibility and allocation determination appeals.

There has been a total of thirty-eight appeals filed and perfected pursuant to the Master Settlement Agreement and the previously issued Case Management Order Regarding Master Settlement Agreement Eligibility and Allocation Determination Appeals Process. All but fifteen of those appeals have been either withdrawn or resolved. Of the remaining fifteen Claimants who have perfected appeals¹, there are three categories of appeal presented:

- (2) Eligibility Proof of ONJ Requirement
- (3) Allocation Category 4 Resection Surgery
