IT IS HEREBY ORDERED that Pretrial Order ["PTO"] No. 4, Section V.D.1 and PTO No. 10 are supplemented as follows:

- 1. <u>Initial Wave Due Dates for Response</u> Each plaintiff whose case was transferred to this Court before the entry of PTO No. 10 on March 19, 2002, including those cases that contain class action allegations, shall have until May 3, 2002 to complete and serve upon defendants a responsive Plaintiff's Fact Sheet and Authorizations required therein. For purposes of this Pretrial Order, a case is deemed transferred to the MDL either: (a) on the date that the certified copy of the applicable Conditional Transfer Order issued by the Judicial Panel on Multidistrict Litigation ("JPML") is entered in the docket of this Court, or (b) where transfer is contested, the date of transfer in any subsequent order from the JPML.
- Document Production Date Such plaintiffs shall have until May
 20, 2002 to produce all documents responsive to the document requests therein.
 Supplemental information and authorizations should be served upon counsel for defendants as they become available for production.

- 3. <u>Later Filed Cases</u> In accordance with PTO No. 4, section V.D.1, for those cases transferred to this Court subsequent to March 19, 2002, each plaintiff shall have 45 days from the date of transfer to complete and serve upon defendants a responsive Plaintiff's Fact Sheet and Authorizations required therein and 60 days to produce all documents responsive to the document requests therein. Supplemental information and authorizations should be served upon counsel for defendants as they become available for production.
- 4. <u>Service</u> In lieu of the standard service requirements set forth in PTO No. 4, Section II., each plaintiff shall serve his or her Plaintiff's Fact Sheet, authorizations and responsive documents directly on the following counsel for defendants:
