JOINT MOTION TO AMEND THE COURT'S ORDER DATED NOVEMBER 30, 2009, AUTHORIZING DISTRIBUTION OF MDL 1 SETTLEMENT FUND

On November 24, 2009, The Plaintiffs' Steering Committee ("PSC") and Defendants filed a Joint Motion for an Order Authorizing Distribution of MDL 1 Settlement Fund. In their motion, the parties asked the Court for an order: (1) authorizing the transfer of funds from the Settlement Fund of the MDL 1 Propulsid Resolution Program ("MDL 1 Program") to the Canadian Prepulsid Resolution Program; (2) authorizing the distribution of funds from the Settlement Fund of the MDL 1 Propulsid Program (in an amount equal to the transfer to the Canadian Program) for charitable purposes consistent with the purposes of the MDL 1 Program; and (3) authorizing the return of the unused balance of Program funds to the Defendants upon completion of the MDL 1 Program.

On November 30, 2009, the Court granted the parties' joint motion. In paragraph one of its order, the Court authorized the transfer of \$8.75 million (Canadian) from the Settlement Fund of the MDL 1 Propulsid Resolution Program Fund to the Prepulsid Resolution Program, the

exact exchange rate to be determined on the date of the entry of its Order (November 30, 2009).

Because the exchange rates can fluctuate daily and this transfer is expected to take place on

December 3, 2009, the parties request that the Court amend its November 30, 2009 order to

reflect that the exchange rate is to be determined on the date of the transfer.
