

IT IS FURTHER ORDERED that Russ M. Herman, Plaintiffs' Liaison Counsel, on behalf of the Plaintiffs' Steering Committee, shall take all actions necessary to see that the above distributions are made from the Attorneys' Fee Fund of MDL 1355 that is held at Deutsch Bank.

IT IS FURTHER ORDERED that any remaining funds, following these distributions, held at Deutsch Bank in the Attorneys' Fee Fund of MDL 1355, be distributed to Plaintiff's Liaison Counsel, Russ M. Herman, for the purposes of winding down this litigation and to pay outstanding expenses incurred or to be incurred. If funds remain following payment of additional costs and expenses, Russ M.
