ORDER

Considering the Plaintiffs' Liaison Counsel's Motion for Final Distribution of Remaining Funds (MDL Settlement Program);

IT IS ORDERED BY THE COURT that the Clerk is authorized and directed to draw a check on the funds on deposit in the registry of this Court in the principal amount of \$397,860.00, plus all interest earned, less the assessment fee for the administration of funds, payable to Russ M. Herman, Plaintiffs' Liaison Counsel, Herman Gerel, LLP, 820 O'Keefe Avenue, New Orleans, LA 70113 and mail or deliver the check to Russ M. Herman.

IT IS FURTHER ORDERED that the distribution of the remaining funds, which include the funds held by Plaintiffs' Liaison Counsel totaling \$110,376.02, the funds being disbursed by Deutsche Bank Attorney's Fee Fund which total \$125,745.97, and the funds in the PTO No. 16 Litigation which total \$397,860.00, plus interest, shall be distributed to counsel as follows:

Upon conclusion of these enumerated functions, Plaintiffs' Liaison Counsel, Russ M. Herman, shall be relieved of his duties.
