## JOINT MOTION TO TERMINATE PLAINTIFFS STEERING COMMITTEE

In accordance with the Court's Case Management Order (Doc. 2873; filed 4/28/15), the Plaintiffs' Steering Committee ("PSC") hereby respectfully moves this Court to disband the current leadership structure. The vast majority of PSC members will soon have no remaining cases in this MDL docket and therefore no longer have a vested interest.

On December 5, 2012, this Court entered an Order Concerning Plaintiffs' Counsel
Organizational Structure appointing the PSC. Order Concerning Plaintiffs' Counsel
Organizational Structure, doc. 127, filed 12/5/12. In its Order, the Court appointed twenty-two
(22) lawyers to the Steering Committee<sup>1</sup>. Two (2) lawyers were appointed as co-lead counsel<sup>2</sup>,

six (6) were appointed as members of the Executive Committee<sup>3</sup>, and two (2) were appointed as liaison counsel<sup>4</sup>.

On December 30, 2013 an Amended Order Regarding Plaintiffs' Organizational Structure was entered. Amended Order Regarding Plaintiffs' Organizational Structure, doc. 1154, filed 12/30/13. As no objections were filed to the applications for appointment/reappointment to the structure, the amended PSC appointments became effective January 1, 2014. Three (3) PSC members from the previous appointment were terminated<sup>5</sup> and three (3) were newly appointed<sup>6</sup>.

Finally, on December 22, 2014 an Order Reappointing Plaintiffs' Organizational Structure was entered. Order Reappointing Plaintiffs' Organizational Structure, doc. 2806, filed 12/22/14. As no objections were filed to the applications for reappointment to the structure, all PSC members were reappointed. The Current PSC consists of the following:

On February 3, 2014, a Master Settlement Agreement (MSA) was approved by this

Court. It is expected that the MSA will result in the settlement of roughly 1,725 cases. Of the

1,725 cases expected to settle, 1,675 are already settled and 921 have already been fully funded.

All PSC members, with the exception of four (4), have settled or are in the process of finalizing

settlement of all of their cases under the terms of the MSA and in a few limited cases are seeking

to be relieved as counsel of record or will be substituted by other counsel. The four (4)

exceptions are:

Brenda S. Fulmer of Searcy, Denney, Scarola, Barnhart & Shipley;

Lawrence L. Jones of Jones Ward;

Wayne Fisher of Fisher, Boyd, Brown & Huguenard; and (clients are now represented by

Justin Presnal); 10 and

Navan Ward, Jr. of Beasley Allen Law Firm

As such, the PSC respectfully seeks the dissolution of the current PSC in light of the Court's

appointment of a new PSC to be responsible for the litigation of the remaining cases pending in

the MDL.

Further, as proposed at the preceding Case Management Conference, Thomas R. Anapol

and Robert T. Dassow remain willing and prepared to continue to serve on a new PSC in a

limited capacity as interim liaison counsel as long as the Court deems necessary. As interim liaison counsel, they will be responsible for any additional motions relating to this MSA and any cases that have been settled pursuant to this MSA. They will also be responsible for transferring the common benefit work to the new PSC, once appointed, and will continue to assist the new PSC and the Court by providing historical perspective or insight on outstanding issues.

Biomet has reviewed said motion and advised that they have no objection. For the foregoing reasons and pursuant to the Court's Case Management Order (Doc. 2873; filed 4/28/15), the PSC respectfully moves this Court to dissolve the PSC.
