AND NOW, this 2nd day of May 2016, upon consideration of the Pfizer Defendants' Motion and Amended Motion for entry of separate and final judgment pursuant to Federal Rule of Civil Procedure 54(b) [MDL Docs. 1578, 1583], and the response thereto, it is hereby ORDERED that the Motions are GRANTED.
