**DECLARATION OF WILLIAM T. GIBBS, PURSUANT
TO THIS COURT'S ORDER DATED MARCH 28, 2018 (ECF: 9833)**

I, **WILLIAM T. GIBBS**, declare the following, pursuant to 28 U.S.C. § 1746:

1. I am an attorney licensed to practice law in the State of Illinois, and a partner in the law firm of Corboy & Demetrio, P.C.

2. All matters stated herein are personally known to me, and if called as a witness in this matter, I could competently testify thereto.

3. Corboy & Demetrio, P.C. is listed as one of the firms entitled to payment from the Attorneys' Fees Qualified Settlement Fund and hereby answers the following questions presented by the Court:

1. How many Settlement Class Members have you, your law firm or any attorney associated with you law firm:

A. Previously represented in this litigation and do not currently represent?

Answer: Corboy & Demetrio previously represented and does not currently represent four (4) Settlement Class Members.

B. Currently represent in this litigation?

Answer: Corboy & Demetrio currently represents fifty-six (56) Settlement Class Members.

2. How many Settlement Class Members previously or currently represented by you, your law firm or any attorney associated with your law firm:

A. Have received a Monetary Award?

Answer: Two (2) Representative Claimants have received payment.

B. Have been informed that they are entitled to receive a Monetary Award?

Answer: Corboy & Demetrio has not been informed of any other Settlement Class Members' Monetary Awards being approved.

C. Have applied for a Monetary Award?

Answer: Corboy & Demetrio has filed seven (7) Settlement Class Members' claims for a Monetary Award.

D. That you have knowledge that they will be eligible to receive a Monetary Award?

Answer: Based on my information and belief, it is likely that an additional twelve (12) Settlement Class Members will be eligible to receive a Monetary Award within the next calendar year. It is premature to speculate if/when others may be eligible.

3. How many Settlement Class Members previously or currently represented by you, your law firm or any attorney associated with your law firm have entered agreements to assign their rights to a Monetary Award ("Assignment(s)")?

Answer: None of the Settlement Class Members that Corboy & Demetrio represents have entered agreements to assign their rights to a Monetary Award.
