**DECLARATION OF DAVID L. MARCUS IN SUPPORT OF PLAINTIFFS' MOTION
FOR AN AWARD OF ATTORNEYS' FEES AND REIMBURSEMENT OF EXPENSES**

I, David L. Marcus, declare as follows:

1. I am an attorney duly licensed to practice before all courts of the Western District of Missouri and the District of Kansas and the States of Missouri and Kansas. I am a partner at the law firm of Graves Bartle Marcus & Garrett, LLC, Class Counsel for Plaintiffs and Class Members in the above-captioned action. I have personal knowledge of the matters stated herein and, if called upon, I could and would competently testify thereto. I submit this declaration in support of Plaintiffs' Motion for an Award of Attorneys' Fees and Reimbursement of Expenses.
2. Graves Bartle Marcus & Garrett, LLC has conducted analysis, investigation and drafting in this matter, as detailed in the Declaration of Lead Counsel.
3. My firm performed extensive work in researching and drafting federal court complaints, interviewing numerous plaintiffs and compiling responses. In particular, my firm spent substantial time and effort on review of documents produced by Defendants.
4. Based on review of our time and expense reports, the total lodestar for Graves Bartle Marcus & Garrett, LLC is \$6,804.00.
5. Graves Bartle Marcus & Garrett, LLC's rates, which were used for the purposes of calculating the lodestar here, are based on prevailing fees for national class-action and complex

work. GBMG's rates for attorneys and staff were approved in *Katie Kindler, et al., v. Mitsubishi Motors Credit of America, Inc., et al.*, United States District Court, Western District of Missouri, Civil Action No. 4:09-cv-00315-ODS (Matthew V. Bartle \$435, David L. Marcus \$370, Nichole Kruger \$140, Molly Bingaman \$140). The court approved an award of attorney's fees to GBMG in a *qui tam* action captioned, *United States of America, ex rel. Saleamua, Inc. v. Cardinal Health, Inc.*, United States District Court, Western District of Missouri, Case No. 4:08-cv-0848-ODS (Matthew V. Bartle \$440, David L. Marcus \$390, Nathan F. Garrett \$415, Nichole Kruger \$160, Rachel Buchholz \$135). A request for attorney's fees is currently pending approval in Consolidated Cause *Jamila Swift, et al. v. Direct Buy, Inc., et al.*, United States District Court, Northern District of Indiana, Cause No. 2:11-cv-00401-TLS-PRC (Matthew V. Bartle \$425, David L. Marcus \$390, Nichole Kruger \$135, Rachel Buchholz \$135, Molly Bingaman \$160).
