**PSC’S MOTION FOR RELEASE OF COMMON BENEFIT FUNDS**

The Plaintiffs’ Steering Committee (“PSC”) respectfully requests that the Court release common benefit funds being held in trust for the PSC and its representatives pursuant to Practice and Procedure Order No. 6 (“PPO-6”) for the payment of common benefit litigation expenses. The continued prosecution of this litigation after eight years – in particular, the extensive and still ongoing *Daubert* proceedings on various issues – is expensive. PPO-6 provides for the periodic release of PPO-6 trust account funds for such purposes as the Court deems appropriate. The PSC thus seeks release of \$600,000 of the PPO-6 trust account funds to pay for ongoing and future common benefit expenses. Good cause exists for release of the funds. A supporting memorandum accompanies this motion.
