On November 12, 2009, the Court directed the Clerk of the Court to remove all individual counsel from the Master Docket in 09-md-2100-DRH-PMF, leaving only Lead and Liaison Counsel as Counsel of Record in the Master Docket. Accordingly, only Lead and Liaison Counsel may file pleadings in the Master Docket in 09-md-2100-DRH-PMF. Attorney Jeffrey Lowe is not Lead or Liaison Counsel for 09-md-2100-DRH-PMF.
