**PLAINTIFFS' STEERING COMMITTEE'S NOTICE OF FILING  
[PROPOSED] ORDER TO SHOW CAUSE CONCERNING REMAND AND TRANSFER**

The Plaintiffs' Steering Committee hereby provides notice of the proposed order to show cause concerning remand and transfer filed herewith.

As explained during the last status conference, the PSC originally contemplated a proposed order that only required attorneys in the "remaining clinic cases" (as defined in the attached) to show cause if they objected to remand or transfer. During the status conference, Box Hill expressed a preference for, or at least an interest in, remand/transfer. Since then, the PSC has heard from plaintiffs' attorneys in the Box Hill and/or Premier cases who are considering whether remand may be appropriate. The proposed order therefore provides an opportunity for counsel in the Box Hill and Premier cases to provide their views on whether remand/transfer is appropriate.
