ORDER

Pending are Zoe Littlepage’s Motion for Allocation From Plaintiffs’ Common Benefit Fee Committee (Doc. No. 3221) and Rainey Booth’s Motion for Allocation From Plaintiffs’ Common Benefit Fee Committee (Doc. No. 3223). In the motions, The Littlepage Firm and Rainey C. Booth, P.A. request that they be treated as two separate firms, rather than the single firm Littlepage Booth. Both motions are DENIED.

Also pending is Plaintiffs’ Motion for Disbursement of Common Benefit Funds (Doc. No. 3284), which requests the disbursement of “only the ‘hard’ costs or out-of-pocket expenditures firms have incurred in connection with the litigation.”¹ No objection have been filed and the time for doing so has passed.

The Motion is GRANTED. The Trustee of the MDL-1507 Common Benefit Fee and Cost Account is authorized and directed to pay the “Total” amount to each of the corresponding law firms below. If a law firm disagrees with the way its firm name is listed, counsel should forthwith contact the Trustee directly, so that he may use the appropriate name.
