**ZOE LITTLEPAGE’S AND ERIK WALKER’S SUBMISSION  
OF AGREEMENT RE: COMMON BENEFIT FUND**

This agreement is among Zoe Littlepage, Littlepage Booth, Erik Walker and Hissey Kientz, LLP regarding the Court’s July 17 and 24, 2014 orders. The parties have resolved all remaining Littlepage / Walker issues and Ms. Littlepage agrees with the Common Benefit Fee Committee’s recommendation that the Court award \$2 million in additional attorney’s fees from the Holdback Fund to Hissey Kientz, LLP. This sum is in addition to the recommended percentage fee allocation for Hissey Kientz, LLP outlined in the CBFC’s July 14, 2014 filing. This agreement makes the CBFC vote in favor of Mr. Walker’s supplemental allocation unanimous. Mr. Walker agrees that this is a fair resolution of all matters relating to common benefit fee allocations for Hissey Kientz, LLP.

Mr. Walker and Ms. Littlepage jointly request that the Court adopt the CBFC’s pending recommendations as to the distribution of common benefit fee allocations and order such distribution promptly.
