The Court concludes that the PSC has satisfied the requirements of CMO 14 for requesting modification of the common benefit attorney fee holdback assessment, both by obtaining unanimous consent by the PSC and with consent of the state court jurisdictions, as well as setting forth the reasons supporting an increase in the assessment for the ATE cases.
