ORDER

IT IS HEREBY ORDERED that, a settlement process will be established for the remaining unresolved cases identified on Exhibit A that are pending before this Court. Once a month for the next four months, counsel for Bard and Davol and plaintiff's counsel shall meet in an in-person settlement conference to discuss resolution of those cases listed on Exhibit A.

In-person settlement conferences will be held on October 30 and 31, 2014; November 19 and 20, 2014; December 17 and 18, 2014; and January 14 and 15, 2015. The in-person settlement conferences shall be held at the United States District Court for the District of Rhode Island Courthouse, located at One Exchange Terrace, Providence RI 02903 (rooms to be determined).

Within seven (7) days of the date of this Order, plaintiff's counsel for those cases identified on Exhibit A shall select one of the above sessions to attend, and notify, in writing, John Hooper of Reed Smith (counsel for Bard and Davol), and Donald Migliori of Motley Rice as Plaintiffs' Liaison Counsel, in order to aid in the scheduling of, and preparation for, a settlement conference. Counsel for Bard and Davol will use best efforts to accommodate all requests, but availability will be on a first-come-first-served basis. Once a settlement conference is confirmed, plaintiff's counsel must seek leave from this Court if they are unable to attend a confirmed conference.

Not later than two (2) weeks prior to the selected settlement conference, plaintiff's counsel shall present a settlement demand and categorize their case(s) and provide settlement review materials which can include, but are not limited to, key medical records, medical holdback and/or lien information to counsel for Bard and Davol. Plaintiff's counsel and counsel for Bard and Davol shall meet and confer sufficiently far in advance of the deadline to identify any remaining materials, if at all, to be provided in advance of the two (2) week deadline.

With respect to the following cases that were originally filed in this Court, they must attend the session on October 30 and 31, 2014, which they shall confirm in writing to Reed Smith, within seven (7) days of the date of this Order:
