**[PROPOSED] ORDER GRANTING ATTORNEYS' FEES AND
REIMBURSEMENT OF EXPENSES**

1 On July 13, 2012, the Court held a hearing on plaintiffs’ motion for approval of the
2 Settlement Agreement and Release (“Settlement”) and on class counsel’s motion for an award
3 of attorneys’ fees, reimbursement of expenses, and service awards for the class
4 representatives. The Court heard from counsel for the parties, and considered all objections to
5 the Settlement and the application for fees, expenses, and service awards.

6 On August 10, 2012, the Court issued an Order granting in part and denying in part
7 Plaintiffs’ request for Attorneys’ Fees and Costs (the “Order”). The Order granted fees and
8 expenses to Co-Lead Counsel and JCCP Liaison Counsel equal to the loadstar and expenses
9 provided to the Court and denied fees and expenses to all other plaintiffs’ counsel. However,
10 the Order stated in footnote 3 that any counsel for plaintiffs that had not previously submitted
11 a detailed declaration in support of an application for fees could do so at a later time and the
12 Court would consider all such submissions.

13 Having now obtained all supplemental detailed fee and expense declarations the Court
14 makes the following ruling on the payment of attorneys’ fees and reimbursement of expenses.

15 The Court GRANTS plaintiffs’ counsel Attorneys’ Fees and Expenses, and orders as
16 follows:
