1 I, R. Brent Irby, declare as follows:

2 1. I am a member of the firm of McCallum, Hoaglund, Cook & Irby, LLP. I am
3 submitting this declaration in support of my firm's application for an award of attorneys' fees
4 and expenses in connection with services rendered in the above-entitled action.

5 2. The firm is counsel of record for plaintiff David C. Perdue. Our firm was not
6 appointed lead counsel in this consolidated MDL. I have not ever been paid or reimbursed any
7 fees or expenses in this case as of the filing of this document.

8 3. The identification and background of my firm and its partners is attached hereto
9 as Exhibit A.

10 4. Attached to this Declaration as Exhibit B is a detailed breakdown and billing of
11 the attorney time and expenses my firm has expended and incurred in this litigation. As
12 evidenced by Exhibit C attached hereto, I had previously provided this same breakdown and
13 billing record to Lead Counsel in this case on April 27, 2012. I provided this breakdown of
14 attorney time and expenses incurred by my firm to Lead Counsel with the expectation that the
15 information would be provided to the settlement Court in the request for fees and reimbursement
16 of expenses. Lead Counsel subsequently provided me and other non-lead attorneys with a
17 suggested declaration to submit that was in the same form as the declarations submitted by Lead
18 Counsel in their application for fees. I utilized and submitted the form declaration suggested by
19 Lead Counsel with the understanding that either it was sufficient for submission or that my
20 previously-provided detailed attorney time and expense records would be submitted along with
21 my declaration. My detailed breakdown and billing of attorney time and expenses incurred by
22 my firm was not provided by Lead Counsel to the Court along with my declaration. In any
23 event, I am attaching to this Declaration as Exhibit B a breakdown and billing of the attorney
24 time and expenses incurred by my firm in this litigation.

25 5. The information contained on Exhibit B regarding my firm's time and expenses is
26 taken from time and expense printouts prepared and maintained by my firm in the ordinary
27 course of business. I am the attorney who oversaw and/or conducted the day-to-day activities in

1 the litigation and who reviewed these printouts (and backup documentation where necessary or
2 appropriate). The purpose of these reviews was to confirm both the accuracy of the entries on
3 the printouts as well as the necessity for and reasonableness of the time and expenses committed
4 to the litigation. As a result of these reviews, reductions were made to both time and expenses
5 either in the exercise of billing judgment or to conform to the firm's guidelines and policies
6 regarding certain expenses such as charges for hotels, meals, and transportation. As a result of
7 these reviews and adjustments, I believe that the time reflected in the firm's lodestar calculation
8 and the expenses for which payment is sought are reasonable in amount and were necessary for
9 the effective and efficient prosecution and resolution of the litigation.

10 6. The total number of hours spent on this litigation by my firm is 21.6. (*See* Ex. B.)
11 The total lodestar amount for attorney/paraprofessional time based on the firm's current rates is
12 \$9,720.00. The hourly rates shown below are the usual and customary rates charged for each




