I am counsel of record for Mr. William Preskins.

Pursuant to your Order of March 14, 2016 [Doc. 844], my Plaintiff hereby objects to the Case Management of Order Regarding Settlement Agreement and Proposed Letter to State Court Judges attached to the correspondence sent to the Court by Andrew Campbell, counsel for Zimmer, on March 11, 20156 [Doc. 843]. Specifically, the above referenced Plaintiff joins and adopts the augments set forth in the letter brief submitted by Plaintiffs' co-liaison counsel, Waters & Kraus, on March 21, 2016 [Doc. 853]. On the basis of those arguments, we ask that the Court: (1) **not** enter the Proposed Case Management Order Regarding Settlement Agreement; and (2) **not** circulate the Proposed Letter to State Court Judges.
