SCHEDULING ORDER FOR FIRST TWO BELLWETHER TRIALS

The schedule for the first bellwether trial will be as follows:¹

- February 16, 2006 Plaintiffs must :
- (a) disclose “liability” experts for the two trial plaintiffs;
 - (b) serve the Rule 26 (a)(2)(B) reports for those experts; and
 - (c) provide Defendants with dates -- which, if possible, should fall between February 16, 2006 and April 14, 2006 -- when the experts are available for deposition.
- February 20, 2006 Wyeth and Pfizer must:
- (a) disclose generic breast cancer causation experts;
 - (b) serve the Rule 26 (a)(2)(B) reports for those experts; and
 - (c) provide Plaintiffs with dates -- which, if possible, should fall between February 20, 2006 and April 14, 2006 -- when the experts are available for deposition.
- March 3, 2006 Plaintiffs must:
- (a) disclose case-specific experts for the two trial plaintiffs;
 - (b) serve the Rule 26 (a)(2)(B) reports for those experts; and
 - (c) provide Defendants with dates -- which, if possible, should fall between March 3, 2006 and April 14, 2006 -- when the experts are available for deposition.
- April 20, 2006 Wyeth and Pfizer must:
- (a) disclose “liability” experts and case-specific experts for the two trial plaintiffs;
 - (b) serve the Rule 26 (a)(2)(B) reports for those experts; and
 - (c) provide Plaintiffs with dates -- which, if possible, should fall between April 20, 2006 and May 12, 2006 -- when the experts are available for deposition.
- May 19, 2006 *Daubert* and dispositive motions must be filed.

¹All pleadings, response, disclosures, etc must be filed by 5 p.m. on the deadline date.

June 5, 2006	Responses to <i>Daubert</i> and dispositive motions must be filed.
June 12, 2006	Replies to <i>Daubert</i> and dispositive motions must be filed.
June 28, 2006	Pretrial disclosure sheet must be filed
July 7, 2006	Objections to Pretrial disclosure sheets must be filed.
July 10, 2006	Motions in <i>limine</i> must be filed.
July 13, 2006	Hearing on <i>Daubert</i> motions.
July 17, 2006	Oppositions motions in <i>limine</i> must be filed.
July 31, 2006	First bellwether trial commences
October 10, 2006	Second bellwether trial commences
