ORDER

THIS CAUSE came before the Court on the PLC's Proposal to Relieve Existing PSC and Appoint New PSC [ECF No. 1413]. The Court previously entered Case Management Order No. 1 and Orders dated October 10, 2009 [ECF No. 144], February 12, 2010 [ECF No. 373], July 6, 2010 [ECF No. 566], and August 19, 2010 [ECF No. 640], appointing Plaintiff's Lead and Liaison Counsel, and various counsel as members of the Plaintiffs' Steering Committee ("PSC"). The cases against GSK and P&G have been separated for purposes of discovery, trials and remand, including by the Court's most recent entry of the September 12, 2011 Scheduling Order applying to Fixodent and mixed Fixodent-SuperPoligrip personal injury cases and the prior stay entered as to GSK, which runs through December 15, 2011.

The Court finds that the PSC has fulfilled its obligations as to SuperPoligrip-only cases. Being fully advised, it is

ORDERED AND ADJUDGED as follows:

1. The original PSC is relieved of its responsibilities.


